and no formal qualifications and it is impossible for me to get employed in a similar position earning the

same salary as there are may people is this field with higher qualifications and education. I am still

unemployed and survive by doing odd jobs. I am in no position to pay any of my creditors."

 - 2.2. Institute or defend on behalf of the estate any action or other legal proceedings of a civil nature for the recovery of monies due to the corporation or otherwise and subject to the provisions of any law relating to criminal procedure, institute any criminal proceedings;
