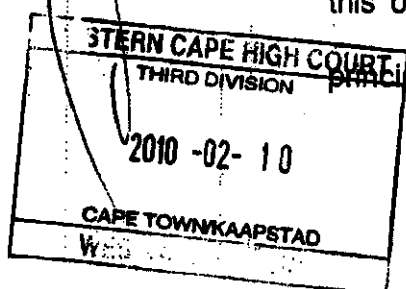


IT IS ORDERED THAT:

1. The Fifth Respondent, Kapula Candles (Pty) Ltd is placed under a provisional winding up order in the hands of the Master of the High Court.
2. A Rule Nisi is issued calling upon all persons concerned to appear and show cause, if any, on 16 March 2010 as to:
 - (a) why a final winding-up order should not be granted; and
 - (b) why the costs of this application should not be costs in the winding-up.
3. Service of this order shall be effected:
 - (a) at the registered office of the Fifth Respondent;
 - (b) on the employees of the Fifth Respondent by affixing a copy of this order on the staff notice board at the Fifth Respondent's principal place of business at 13 Cereal Street, Bredasdorp;



- (c) by one publication in each of the Cape Times and Die Burger newspapers;
- (d) on the South African Revenue Services;
- (e) by certified post to all creditors with claims against the Respondent in an amount in excess of R1 000-00.
