- 5.2 by service on the South African Revenue Services at George, Western Cape;
- 5.3 by service on the registered office of the Respondent at 35 York Street, George, Western Cape;
- 5.4 by service on the employees of the Respondent, if any; and
- 5.5 by service on all registered trade unions which represent any employees of the Respondent, if any.
6. Ordering that the costs of this application be costs in the liquidation.
