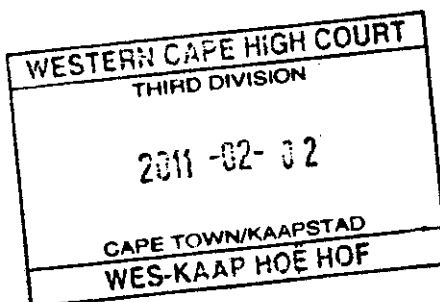


**IT IS ORDERED THAT:**



