Causes of the Close Corporation's failure

There were two creditors who had registered notarial bonds over the movable assets of the Close Corporation. The creditors got court orders and the notarial bonds were perfected. After sale of the assets the Close Corporation was left with no assets and various liabilities and could no longer trade. This led to the Close Corporation closing down as it could no longer trade.
