UPDATE ON FIRST MEETING OF CREDITORS HELD ON 25 NOVEMBER 2020

FIRST MEETING

The First Meeting of Creditors was convened by the Master of the High Court in the Government Gazette dated 13 November 2020 to take place on 25 November 2020 at 10h00, Master of the High Court, Johannesburg.

PROCEEDINGS

The Presiding officer officially started the meeting at approximately 11h45.

The Presiding officer requested parties in attendance to confirm that the meeting can proceed at the venue and that the social distancing is adequate.

Parties recorded attendance on the Minutes of the Meeting.

The Presiding officer confirmed receipt of a letter from the insolvent’s doctor requesting that the insolvent be excused from the meeting.

Presiding Officer renumbered the claims. A total number of 48 claims were submitted for proof.

Claims 1 - 4 - submitted by BDO;

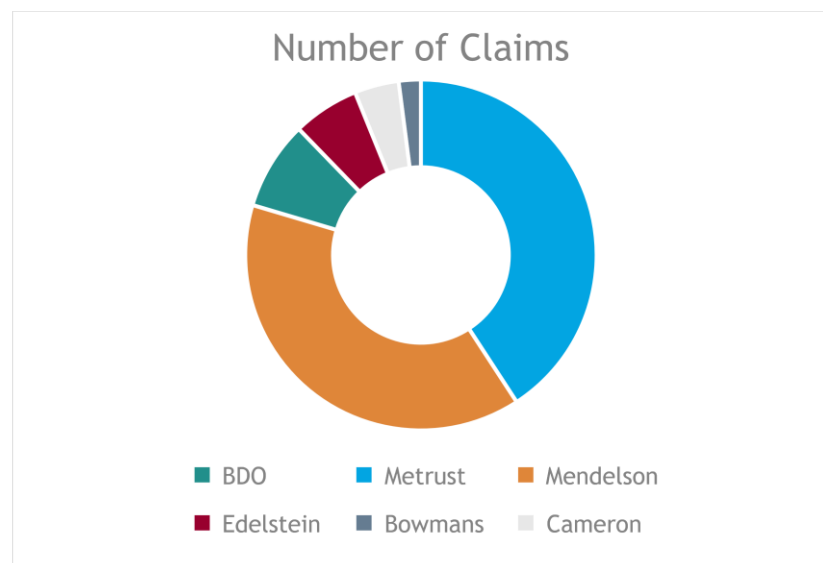
Claims 5 - 24 - submitted by Metrust

The meeting was postponed until 2 December 2020.

GENERAL

Certain creditors requested the Master to provide them with copies of the claims prior to the meeting of creditors. The Master advised that their offices do not provide copies of claims to creditors. However, during the meeting Mr John Cameron “Cameron” advised that the Master provided him with copies of the claims on or about 29 September 2020 (Cameron confirmed that he paid a fee for the copies).

The presiding officer indicated that the claims will be numbered according to the time in which the claims were lodged. Cameron’s claims remained on the Master’s file from 29 September 2020 however the Master elected to record the two claims last.

The insolvent notified the trustees that Mr Jeff Mendelson is on record for him however during the meeting Mr Mendelson advised that he is not on record for the insolvent. The trustees received a notice from the insolvent via email at 12h06 confirming that he lodged documents at the Master to be excused from the meeting.

The presiding officer postponed the meeting until 2 December 2020 in order to allow him to examine the claims.
