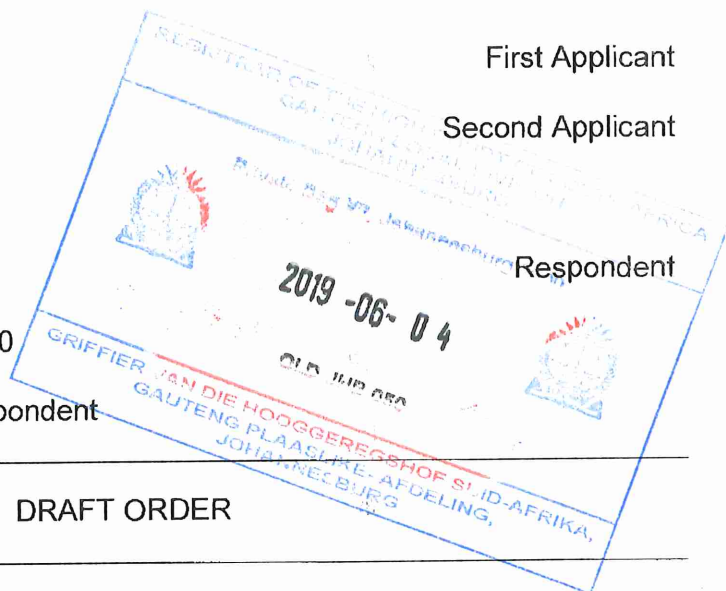

2. The first and second intervening creditors' provisional order of sequestration



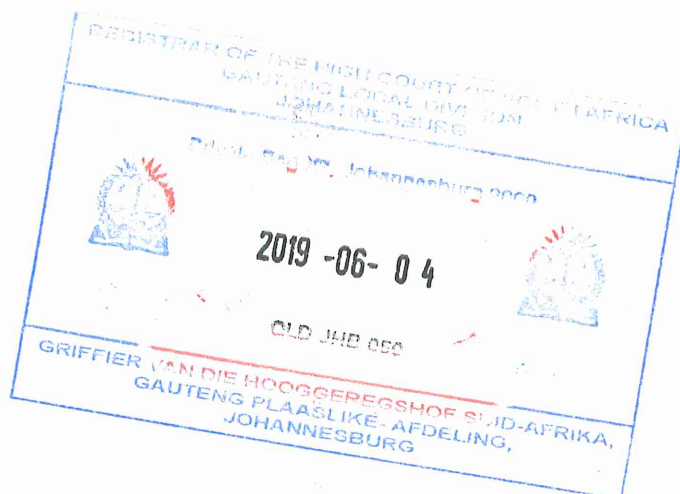
granted on 23 April 2019 is made final.
