

- 3.3 By the sheriff upon the South African Revenue Services, by delivery of a copy of this order to its office; and
- 3.4 By registered post to all creditors of the Respondent known to the Applicants with claims in excess of R25 000.
- 4. In terms of section 357(a) of the Companies Act, 61 of 1973 read with section 19 of the Insolvency Act, 24 of 1936:
 - 4.1 The Registrar shall transmit a copy of the winding up order to the Sheriff of the province in which the registered office of the Respondent is situate and to the Sheriff of every province in which it appear that the Respondent owns business; and
 - 4.2 The Sheriff shall attach all property which appears to belong to the Respondent and transmit to the Master an inventory of all property attached by him or her in terms of Section 19 of the Insolvency act, 24 of 1936.
