### FOUNDING AFFIDAVIT



I, the undersigned,

#### BAMBANGAZIBINI VUYO TABATA

do hereby state under oath as follows:

1.



- 1.1. I am an adult male and I am duly authorized on behalf of the Applicants to depose to this affidavit in support of these proceedings against the Respondents.
- 1.2. The facts deposed to in this affidavit are true and correct and fall within my personal knowledge save where otherwise stated.
- 1.3. I will, in many instances, refer to the opinions expressed by suitable qualified specialists, including accountants and business rescue practitioners. Confirmatory affidavits from the appropriate individuals will be annexed at the end of this affidavit.

#### A: THE APPLICANTS

2.

2.1. The First Applicant is **TFM HOLDINGS (PTY) LTD**, a company with limited liability, duly registered as such in accordance with the company laws of the Republic of South Africa, which has its registered office at 33 Industry Road, Clayville, Extension 4, Olifantsfontein, Gauteng.



- 2.2. The Second Applicant is RITHAM HOLDINGS (PTY) LTD, a company with limited liability, duly registered as such in accordance with the company laws of the Republic of South Africa.
- 2.3. The Third Applicant is **TFM MANUFACTURING (PTY)** LTD, a company with limited liability, duly registered as such in accordance with the company laws of the Republic of South Africa, which has its registered office at 2 Penkop Street, Woodbrook, East London, Eastern Cape.



- 2.4. The Fourth Applicant is **TFM CUSTOMIZING (PTY) LTD**, a company with limited liability duly registered as such in accordance with the company laws of the Republic of South Africa, which has its registered office at 36 Prospectum Drive, Prospectum, KwaZulu-Natal.
- 2.5. The First Applicant is the sole/majority shareholder of TFM Industries (Pty) Ltd (in liquidation), which is the First Respondent (hereinafter referred to as "the company").
- 2.6. The Second Applicant, in turn, holds 94,6% of the shares in the First Applicant.
- 2.7. The Third and Fourth Applicants are creditors of the company. The Third Applicant is the company's creditor due



to goods sold and delivered and services rendered in the amount of R526 070.50 and a creditor for loans in the amount of R305 249.00.

- 2.8. The Fourth Applicant is a creditor of the company for goods sold and delivered and services rendered, and loans in the amount of R2 804 565.00.
- 2.9. Section 128(1) of the Companies Act, 71 of 2008 ("the Companies Act") defines the phrase "affected person" to include "a shareholder or creditor of the company. The Applicants accordingly qualify as "affected persons" and are therefore clothed with the required locus standi to launch this business rescue application.

#### B. THE RESPONDENTS

3.

3.1. The First Respondent is **TFM INDUSTRIES (PTY) LTD** (in liquidation), a private company with limited liability duly registered and incorporated in terms of the Statutes of the Republic of South Africa. with its joint provisional liquidators herein cited as the Second, Third, and Fourth Respondents. This application id to place the First Respondent under business rescue and to commence its supervision under the



provisions of the Companies Act, 71 of 2006. The First Respondent was incorporated in 1966 with registration number 1966/005974/07. A company report for the company is attached hereto and marked **Annexure "FA1"**.

3.2. The Second Respondent is RALPH FARREL LUTCHMAN
N.O, an adult male Insolvency Practitioner with his address at 270 Main Street, Brooklyn, Pretoria.



- 3.3. The Third Respondent is **ANNEKE BARNARD N.O.**, an adult female Insolvency Practitioner and duly appointed provisional liquidator of the company, with her address at 377 Wilma Avenue, Constatiakloof, Roodepoort, Johannesburg
- 3.4. The Fourth Respondent is RANJIT CHOONILALL N.O., an adult male Insolvency Practitioner with his address at 30 Dorothy Nyembe Street, Durban.
- 3.5. The Second, Third, and Fourth Respondents are collectively referred to as "the provisional liquidators" who are the joint liquidators of the First Respondent, being TFM Industries (in liquidation). They are cited here as the liquidators of the company that the Applicants seek to be placed under business rescue.



- 3.6. The Fifth Respondent is **COMPANIES & INTELLECTUAL PROPERTY COMMISSION**, a juristic entity established in terms of section 185 of the Companies Act, 71 of 2008, with its principal place of business situated at DTI Campus, 77 Meintjies Street, Sunnyside, Pretoria.
- 3.7. The Fifth Respondent is joined in these proceedings in compliance with section 131(2)(a) of the Companies Act.



### C. PURPOSE OF THE APPLICATION

4.

- 4.1. This is an application in terms of section 313 of the Companies Act to replace the First Respondent, being the company under discussion, under supervision, and for the commencement of business rescue proceedings.
- 4.2. In their capacities as an affected person, the Applicants submit that although the company is in financial distress, there are reasonable prospects of rescuing the company. In addition, the Applicants believe it would be just and equitable, for financial reasons, to place the company under supervision for financial reasons. If the company cannot be rescued, a better return for creditors than the immediate



winding-up of the company will be achieved by placing the company under business rescue.

4.3. The Applicants further believe that a duly qualified business rescue practitioner will be able to implement the business rescue plan/strategy. The rescue plan will probably be a long-term turn-around strategy that the company, if properly implemented, would not only be beneficial to the company but also to its creditors. The rescue of the company would also restore the employment of its employees and ensure the financial independence of the employee as well as their dependents.



#### D. HISTORIC BACKGROUND

5.

- 5.1. The TFM Group is, and at all material, times has been, a diverse industry with manufacturing capability in the automotive, defence, mining, and building sectors. The company has a long and proud history. It was established in 1966 already.
- 5.2. Companies in the TFM group manufacture, amongst others, waste compactors, ambulances, cash-in-transit vehicles, mining trucks, fire engines, components for the transport



and engineering industry, fuel tanks, trailers of all sizes, and they also perform modifications to truck chassis and supply and installation of hydraulic kits. The company's business is very specialised and there are not many entities that participate in this specific field. This is one of the many reasons that no stone should be left unturned to save the company.

- 5.3. The company was (and is) the lifeline of the entire TFM Group of businesses. Over the years, most of the large transactions undertaken by companies in the TFM Group have been channelled through the company. The company has the required equipment and institution skill and know-how to address the specialised and specific need.
- 5.4. In 2020, during the Covid Pandemic, the company lost the skills and employment of 2 key employees.
- 5.5. Following the resignation of the said two employees, the First Applicant assumed control of the company's management while scouting for suitable replacement personnel.
- 5.6. It was a concern that the two employees would not be easily replaced, and these concerns materialized. This placed tremendous pressure on the Applicants in the continued functioning of their business. These circumstances prompted



the First Applicant to explore the possible sale of the TFM business.

5.7. Mr. Mododowa Ziphiwo Mhlwana (who refers to himself as "Odwa"), which name I will use in reference to him in this affidavit, was appointed as CEO and director of the company with effect from early 2021 or thereabout. He remained at the company's helm until the liquidation of the company. The appointment and retention of Odwa turned out to be a great and costly error. Considerable trust was placed in Odwa.



- 5.8. Odwa was appointed as CEO and director in the wake of the departure during 2020 of two key employees/ individuals mentioned above.
- 5.9. I was made aware of the application for the winding-up of the company prior to the order being granted. The application was made by an entity known as SAFE TYRES (PTY) LTD. Odwa assured me that the application will be dealt with and not result in the liquidation of the company. These undertakings were not complied with. This should be seen in light of the debt on which SAFE TYRES relied for the application, being R221,175.10, which is, considering the magnitude of the company and its business, relatively small,





and could very easily have been dealt with. Although the company did experience financial difficulty, it should never have been wound up.

5.10. During September 2022, Magagula Attorneys called and informed that as per a notice of set down, they received a liquidation application of the company and that same was placed to proceed on an unopposed basis, and that the date was nominated for the same day. This surprised us because Odwa has undertaken to ensure that the liquidation application would be opposed. To affirm this notion, I had a telephonic call with Odwa in the presence of Mogagula Attorneys, who stated to us that he agrees that the matter be opposed.



- 5.11. However, Odwa called Magagula Attorneys on a separate occasion confirming that he would take care of the pending litigation. This was only found out later. He instructed Magagula Attorneys to withdraw as attorneys of record and that his mandate is terminated.
- 5.12. As CEO of the company, this falls squarely within his jurisdiction and control, so Magagula Attorneys implemented the instructions. I refer to the filed notice of intention to oppose from Magagula Attorneys together with a





confirmatory affidavit by Magagula Attorneys marked as

Annexures "FA2" and "FA3".

5.13. It is quite clear from the service of the affidavit in the liquidation application, Odwa, on behalf of the company, received all correspondence pertaining to the matter. See

Annexure "FA4". All correspondence was served upon Odwa's personal assistant at the company's registered address situated at 33 Industry Road, Clayville extension 4, Olifantsfontein.



- 5.14. As a matter of fact and on 16 August 2022, the notice of set down was accordingly sent to by Hutchson Attorneys to Magagula Attorneys. As can be seen, the company filed no answering affidavit, and the order (as it turned out) was granted on an unopposed basis (I refer to the unopposed motion checklist and notice of set down with the granted order, which is marked as **Annexure "FA5"**).
- 5.15. Consequently, Odwa was well aware of the liquidation application development and the status thereof. The Applicants were under the misapprehension that the liquidation proceedings had been opposed because that is what Odwa told the chairman of the First Applicant. He misrepresented the facts of the liquidation and failed to



disclose that he had taken no steps to oppose the application.

It is clear that Odwa as a director of the company, did not act in good faith and directly acted contrary to the provisions of the Companies Act in his fiduciary duties as a director.

5.16. It seems likely that Odwa intentionally derailed the company for his own selfish motives. There are significant pending disputes between the TFM Group and Odwa.



5.17. Odwa (and his management of the business of the company) was, no doubt, the material reason for financial distress experienced by the company.

# E. BACKGROUND TO THE DECISION TO LAUNCH THE BUSINESS RESCUE APPLICATION

6.

6.1. The TFM businesses are all in a precarious position. They need to be carefully managed and traded through their present difficulties. I pause to mention that the TFM Group employs about 400 employees whose continued ability to put food on the table for their families depends on the continued viability of the businesses.



- 6.2. The First Applicant is currently in negotiations with a third party which is all but certain to result in an agreement to the great benefit of the company's businesses.
- 6.3. The expected value of the agreement between TFM Holdings and a third party is expected to exceed R1 billion (One Billion Rand).
- 6.4. There are numerous other possibilities (that would require the skill and services of the company) in development and negotiations.
- 6.5. The First and Second Applicant intends to contract the company's business as a sub-contractor in these processes.

  Accordingly, the First and Second Applicant pursues this business rescue plan in order to proceed to rescue the business and all the employees of the company by placing same under business rescue.
- 6.6. Should the business rescue be successful, it will contribute to saving the employees of the company's employees and the Group's 400-odd employees as well as their dependents.
- 6.7. A successful business rescue would also be in the best interest of the company, Applicants as creditors as well as all other creditors.



6.8. In addition to the aforesaid, the TFM Group of companies secured additional funding in the amount of R25 million from a Spanish company by the name of Aeronautica SDLE. This is part of a contractual project between the Group and Aeronautica SDLE, in terms of which a long-term and lucrative co-operative relationship is planned between the entities. This will, no doubt, be beneficial to the prospects of rescuing the company.



- 6.9. Aeronautica SDLE has agreed to a working capital/contract agreement with our TFM Group. Furthermore, Aeronautica SDLE has agreed to an initial payment injection of R25 million to relieve TFM Industries (Pty) Ltd from all its debts. The latter is due to the significant importance TFM Industries (Pty) will play in fulfilling the contract terms.
- 6.10. Aeronautica SDLE has given a written undertaking to transfer the R25 million to the proposed business rescue practitioner upon granting this Business rescue application, which is the subject matter of the current application. I attach here to the confirmation letter of the agreement reached as **Annexure "FA6"**.



#### F. FINANCIAL DISTRESS

7

- 7.1 I have already alluded to the winding-up application for the company, and Odwa's failure to oppose it, above. In terms of the mentioned application the company was, eventually finally wound-up.
- 7.2 I am advised that the final winding-up of the company should be sufficient to establish the requirement that the First Respondent, as a company prospectively placed under business rescue, is financially distress.
- 7.3 I do, however, wish to address the financial distress experienced by the company, in this affidavit. This should, however, be seen light of the fact that the Applicants, currently, receives no co-operation, information or participation from Odwa, the erstwhile CEO of the company. The Applicants, in addition, receive no co-operation from the provisional liquidators, which the applicant submits is mala fide. The Applicants, in addition, have no access to any company records which would have been under the control of Odwa (prior to winding-up) and which should be under the control of the provisional liquidators. A business rescue



practitioner will, however, have access and insight into these records and documents.

7.4 It should be no surprise that the company was severely affected by the Covid-19 pandemic. The company specialises in the manufacturing production and assembly of numerous types of specialised vehicles, including military vehicles and equipment. The company, and the TFM Group generally, are also well-known for manufacturing, production and assembly of waste-disposal, ambulance, riot-control, and fire-fighting vehicles and equipment.



- 7.5 During the Covid-19 pandemic, and for some time after the lockdown measures had been lifted, most of the TFM Group's customary and normal clients were not placing as many orders or making as many purchases as they used to.
- 7.6 The company, and the group generally, consequently, were financially negatively affected by the Covid-19 pandemic and its consequences.
- 7.7 The group, in addition, also placed far to much trust in Odwa. Odwa caused significant financial deterioration of the company.





- 7.8 The Applicants have no choice but to concede that, considering the impact Odwa was able to have, there were insufficient corporate governance, checks and balances in order to, timeously, identify Odwa's unlawful (and/or prejudicial) conduct and the consequences thereof.
- 7.9 Proper corporate governance procedures and rules can, properly, be implemented by the business rescue practitioner which would, in and of itself, make a significant difference to the company's prospects of being rescued and, once again, conducting business under solvent circumstances.



The Applicants do not have access to the company's financial statements or even management statements. We are, consequently to unable to produce these documents for this Honourable Court's consideration. The provisional liquidators are invited to make available, to this Honourable Court and the Applicants, all such financial documents and records for inspection and consideration. The provisional liquidators have, to date, failed to give the Applicants much consideration or co-operation. It seems that the provisional liquidators have no interest in considering the possibility of rescuing the company. There would, after all, be no personal



benefit to the liquidators should the company be placed in business rescue.

7.11 Despite the provisional liquidators' one-sided view and stance, to date, I doubt whether the provisional liquidators will, actually, go as far as opposing the current application, despite their rights to do so. The Applicants do, however, invite the provisional liquidators to provide relevant information and records.



- 7.12 In the premises the Applicants do not have the necessary access to the records of the company to be able to disclose to this Honourable Court whether the company has failed to pay over any amount in terms of an obligation under, or in terms of, a public regulation, or contract, with respect to employment-related matters, I would have, however, be surprised if such payments have been made.
- 7.13 It is, however, clear that:
  - 7.13.1 the company is financially distressed;
  - 7.13.2 it would otherwise be just and equitable, for financial reasons, that the company be placed under supervision and commencing business rescue proceedings.



#### G. REASONABLE PROSPECTS OF BUSINESS RESCUE

8

8.1 I have already addressed the advances that a business rescue practitioner, and corporate governance specialists, might make in implementing certain corporate government provisions within the company. I can confirm that, prior to the winding-up of the company, the corporate governance structures were insufficient.



- 8.2 The company is, as already stated above, integral to the TFM Group and lucrative contracts awarded within the TFM Group, particularly the First Applicant.
- 8.3 It is within the company that the necessary equipment and institutional skill and knowledge are, in order to comply with the group's obligations in terms of the contracts awarded, particularly the design, structure, production and assembly of specialised vehicles.
- 8.4 I can confirm that the group, particularly the First Applicant, is currently in negotiations for various lucrative contracts for the production, manufacture and assembly of specialised vehicles. One such potential contract, which are currently of



a secret and confidential nature (which is not surprising considering the types of vehicles that are manufactured within the group) is at an advanced stage of conclusion. This particular contract will be valued in excess of R1 billion. The company, and company's participation in such contract, will be integral and essential. The awarding of such contract, to the First Applicant, would, obviously, be to the financial benefit of the company and the company's efforts at financial health generally.



- 8.5 I have already alluded to an agreement with Aeronautica SDLE, a Spanish company which is, generally, in the same business as the TFM Group. A company profile of Aeronautica SDLE is attached hereto and marked **Annexure "FA7**".
- 8.6 The First Applicant is, similarly, in advance stages of concluding an agreement with Aeronautica SDLE for the manufacturing of specialized vehicles.
- 8.7 Aeronautica SDLE has obviously identified the potential in producing, manufacturing and assembling specialized, with the assistance of TFM Group, and the company particularly.
- 8.8 The letter of undertaking, already attached hereto as

  Annexure "FA6", is of particular importance to the current



application. Considering the mentioned letter of intent, the following is evident:

- 8.8.1 the advanced stage of negotiations between the TFM Group and Aeronautica SDLE;
- 8.8.2 that Transfer of Technology will be to TFM Group, in South Africa, which will be done in stages;



- 8.8.3 that an agreement between the group and Aeronautica SDLE is anticipated;
- 8.8.4 that Aeronautica SDLE has agreed, with the only condition being that an order for the business rescue of the company being granted, that R25 million be paid to the company, for the specific purpose of relieving the company's debt;
- 8.8.5 that Aeronautica SDLE is prepared to make this capital injection due to the importance of the company within the TFM Group, and the manufacturing of specialized vehicle process.
- 8.9 The undertaking in the mentioned letter is clear. Once the order that the Applicants no seek is granted, and a provisional business rescue practitioner is appointed, R25 million will be



paid to such practitioner to be implemented in a plan. It is further clear, that the payment is not conditional upon the approval of a business rescue plan, or successful implementation. The R25 million, to be paid by the mentioned entity, can be applied to the creditors of the company even if the company is not successfully rescued. This is relevant to the consideration that business rescue proceedings would be more favourable to employees of the company and creditors than a winding-up of the company. There will, as a worst case scenario, be R25 million more to distribute amongst the company's creditors.



- 8.10 It is, obviously, essential that the assets (including specialised equipment) of the company be preserved to be utilised by the company for manufacturing, production and assembly of these specialised vehicles.
- 8.11 The likely costs of rendering the company able to commence with its intended business, and to resume conduct of its core business, can be considered, initially, by the business rescue practitioner after her appointment.
- 8.12 It is submitted, considering the willingness of Aeronautica SDLE to invest in the group, and particularly the company, that there is likely to be available the necessary cash resources



in order to enable the company to meet its day-to-day expenditure, once its trading operations, production and manufacturing resumes. I reiterate that Aeronautica SDLE has confirmed that, once the business rescue order is granted, the capital injection will immediately be made. Other potential post commencement financiers will, in all likelihood, also be willing to invest and participate in the business (and rescue) of the company due to the potential and prospects of the company.



- 8.13 Considering the above it is submitted that the business rescue practitioner will be able to construct business rescue plan which will have great prospects of success.
- 8.14 In the premises it is submitted that there are reasonable prospects, based on reasonable grounds, that the company will successfully be rescued.

#### H. THE PROPOSED BUSINESS RESCUE PRACTITIONER

9

9.1 The Applicants propose Sumaiya Abdool Gafaar Khammissa ("Khammissa") as business rescue practitioner, to be provisionally appointed in terms of Section 131(4) of the



Companies Act. Khammissa is a recognised business rescue practitioner and satisfies the requirements of Section 138 of the Companies Act. Khammissa is a member, in good standing, of the legal practice counsel, and has been licenced as such by the Fourth Respondent, is not subject to an order of probation in terms of Section 162(7) of the Companies Act, would not be disqualified from acting as a director of the company in terms of Section 69(8) of the Companies Act, does not have any relationship with the company such as would lead a reasonable and informed third party to conclude that the integrity, and partiality or objectivity of Khammissa is compromised by that relationship and is not related to a person who has a relationship contemplated in Section 138(1)(d). Khammissa's consent to act as business rescue practitioner for the company is attached hereto and marked Annexures "FA8". Her CV is attached as Annexure "FA9".



#### I. NOTICE TO AFFECTED PERSONS

10

10.1 The Applicants, through court proceedings with specialised vehicle manufacturer (Pty) Ltd, Odwa's company, obtained a



list of creditors of the company, a copy of which is attached hereto and marked **Annexure "FA10**".

- 10.2 The mentioned creditors, as affected persons in terms of the provisions of the Companies Act, will be notified of this application in the prescribed manner.
- 10.3 The National Union of Metal Workers of South Africa ("NUMSA") and South Africa Congress of Trade Unions ("SACTU"), the unions representing the employees of the company, will be notified of their application in the prescribed manner.



- 10.4 The sole shareholder of the company, the First Applicant, obviously, is aware of this application and has been notified.
- 10.5 The above mentioned are affected persons of the company which the Applicants are aware of.
- 10.6 The Applicants have requested information form the provisional liquidators. One such request is attached hereto and marked **Annexure "FA10"**. The provisional liquidators did not provide the requested information and advised the Applicants to approach a court in terms of Section 360 if the 1973 Companies Act. The Applicants submit that this conduct is unreasonable and obstructive.









### THE LIQUIDATION OF INDUSTRIES

- 33. On 7th September 2022, Magagula Attorneys called and informed me that, as per the notice of set down he received on e-mail, the liquidation application of Industries is proceeding on an unopposed basis and that the date is set for that same day. This came as a surprise to me because Odwa had undertaken to ensure that the liquidation application would be opposed. To affirm this notion, I had a telephonic call to Odwa in the presence of Magagula Attorney, who stated to us that he agrees that the matter be opposed. However, subsequent to that, Odwa called Magagula Attorneys on a separate occasion, confirming that he is going to take care of the pending liquidation and instructed Magagula Attorneys to withdrawal as attorneys of record and that his mandate in this matter is terminated. As CEO of Industries, this fell squarely within his jurisdiction and control and therefore Magagula Attorneys implemented the instruction. [I refer to the filed notice of intention to oppose by Magagula Attorneys on the date together with a confirmatory affidavit of Magagula Attorneys, marked as annexure "AA7.1", and "AA7.2"]
- 34. As quite clear from the service affidavit in the liquidation application, Odwa on behalf of Industries received all correspondence pertaining to the matter. All correspondence was served upon the Odwa's personal assistance at TFM Industries situated at 33 Industry Road, Clayville Ext 4, Olifantsfontein. [See Annexure "AA6"]
- 35. As a matter of fact, on 16th August 2022, the Notice of Set Down was accordingly sent by Hutcheon Attorneys to the Magagula Attorneys. As can be seen, the applicant filed no answering affidavit, and the order (as it turned out) was granted on an unopposed basis. [I refer to the unopposed motion checklist and notice of set down.]

#### RE: TFM INDUSTRIES (PTY) LTD (IN LIQUIDATION)

- 1. We refer to the above and the hearing held on Monday, 30 January 2023.
- We also refer to your response set out in your letter of 15 December 2022, upon
  receiving our Client's request to provide a list of Creditors of the Company in
  Liquidation.
- 3. Your letter dated 2<sup>nd</sup> February 2023 sent to the Master of the High Court Johannesburg (hereinafter referred to as "the Master"), also bears reference.



- 4. Firstly, your letter dated the 2<sup>nd</sup> February 2023 seeks to provide documentation purportedly referred to in argument. It was not contained in your Client's recommendation. We submit that it is improper to provide documents after the argument and without our Client's permission and/or consent.
- 5. Furthermore, your Clients seek to introduce documents selectively. In this regard, and as example, the list of creditors was referred to during the meeting and also argued. The selective nature of providing documents is not accepted and our Client objects thereto.
- 6. We record that to date, the provisional liquidators have not provided any information that the Master can consider (and therefor make an informed ruling thereon) relating to the following:
  - 6.1. All creditors have received notice of your Client's application; and
  - 6.2. Who these creditors are; and
  - 6.3. Whether such creditors are preferent / secured or concurrent.
- 7. We record that your Clients are Provisional Liquidators of the aforementioned entity. We refer to the Certificate of Appointment of Provisional Liquidators issued by the Master of the High Court, Johannesburg, on the 28th of September 2022.
- 8. In addition to the above, our Client requests the following:
  - 8.1. That it be registered as a Creditor in terms of Section 43 of the Insolvency Act, 1936 and to that end our Client request the Estate banking details so that it can deposit the contemplated fee required in terms of that Section;



- 8.2. Confirmation that the Sheriff has made an inventory in terms of Section19 of the Insolvency Act, 1936 and a copy of such inventory;
- 8.3. A copy of the Liquidators' record in terms of Section 390(1) of the Companies Act, No. 61 of 1973 containing a statement of all monies, goods, books, accounts and other documents received by him on behalf of the company;
- 8.4. Provision of the date when a first meeting of Creditors will be advertised in the Government Gazette: and
- 8.5. A list of Creditors.
- As the request has been made previously, we require your urgent response thereto.
- 10. We are of the opinion that your reliance upon Section 360 of the Companies Act, No. 61 of 1973 is misplaced, unreasonable under the circumstances and relied upon for anterior purposes.
- 11. In our letter of the 12<sup>th</sup> of December 2022, we requested information that ought to be made available to Creditors in the normal cause of winding-up. We have not requested anything from your Clients that would not be ordinarily provided to Creditors. The information sought is to verify the following:
  - 11.1. Firstly, that all Creditors have been notified of your Clients' intention to apply for extension of powers under the permission from the Master to

sell the assets of the Company (in liquidation), without the Creditors approval or objection;

- 11.2. To apply for Business Rescue and notify each and every Creditor which the Liquidators are aware of.
- 12. For instance, the request for the provision of this information would normally be contained in the statement of affairs, which is provided for in Section 363(6) BRIGHTON PRINCE PRI
  - "(6) Any person shall be entitled by himself or his agent, on payment of the prescribed fee, to inspect or apply for a copy of or an extract from any statement as to the affairs of a company lodged with the Master in pursuance of this section."
  - 13. We also refer in this regard to Section 393 of the Companies Act, No. 61 of 1973, which provides that:
    - "(1) Immediately after his appointment a liquidator shall open a book or other record wherein he shall enter from time to time a statement of all moneys, goods, books, accounts and other documents received by him on behalf of the company.
    - (2) The Master may at any time in writing require the liquidator to produce any such book or record for inspection.

- (3) Any creditor or contributory may, subject to the control of the Master, at all reasonable times personally or by his agent inspect any such book or record."
- 14. Therefore, kindly provide us with the documents and information requested, if your Clients are in possession of such. If your Clients are not in possession of such information, please advise us if this is the case.
- 15. In the event that your Clients refuse to provide such information, kindly provide sufficient reasons thereto.
