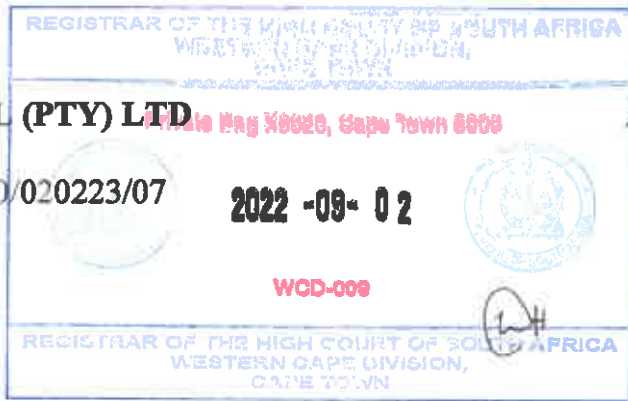

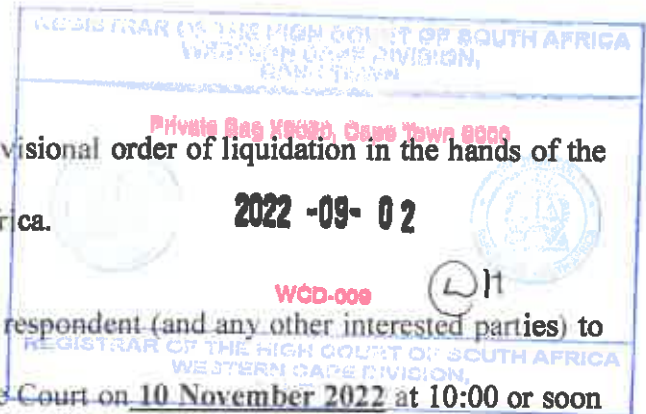

After having read the papers filed of record, and having heard counsel for the applicant, an order is granted in the following terms:

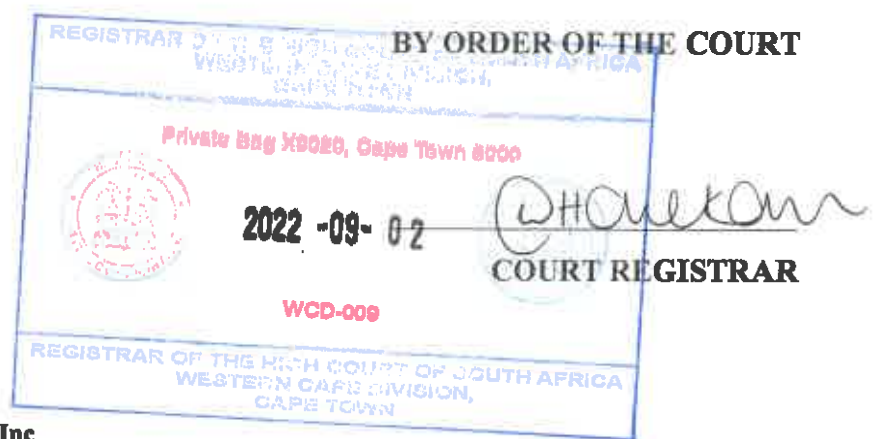
1. The respondent is placed under a provisional order of liquidation in the hands of the Master of the High Court of South Africa.
2. A *rule nisi* is issued calling upon the respondent (and any other interested parties) to show cause, if any, to this Honourable Court on 10 November 2022 at 10:00 or soon thereafter as counsel may be heard, as to why:
  - 2.1. the respondent should not be placed under a final liquidation;
  - 2.2. the costs of this application should not be costs in the liquidation;
  - 2.3. alternative relief should not be granted to the applicant.
3. Service of this order be effected:
  - 3.1. by the Sheriff of this Honourable Court ('the Sheriff') at the respondent's registered address at 133 Voortrekker Road, Bellville, Cape Town;
  - 3.2. by the Sheriff on the respondent's employees by affixing a copy thereof to any notice board to which the employees of the respondent have access to either inside the premises or by affixing a copy thereof to the front door of the premises from which the respondent conducts business;
  - 3.3. by the Sheriff on the respondent's trade union(s) by affixing a copy thereof to any notice board to which the employees of the respondent have access to either



inside the premises or by affixing a copy thereof to the front door of the premises from which the respondent conducts business;

3.4. by the Sheriff on the South African Revenue Services at its offices situated at 22 Hans Strijdom Avenue, Cape Town;

3.5. by one publication in each of the 'Cape Times' and 'Die Burger' newspapers.
