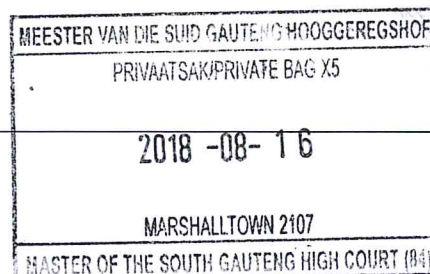

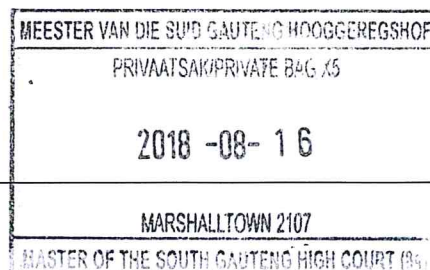



2.
