- 2. Royal Albatross Properties 30 (Pty) Ltd complied with the requirements of Section 129(3)(a) and (b) of the Act.
- 3. Johannes Frederick Klopper was licensed by the Commission in respect of the company and appointed as Joint Business Rescue Practitioners (BRP) to this company on 29 October 2013 in terms of Section 138 of the Act.
- 4. Rynette Pieters was licensed by the Commission in respect of the company and appointed as Joint Business Rescue Practitioners (BRP) to this company on 1 November 2013 in terms of Section 138 of the Act.
- 5. A First Meeting of Creditors was held in terms of Section 147 of the Act on 14 November 2013.

6. Discussions with affected persons and other parties with a view to finalising a business rescue

plan are ongoing. The Business Rescue Plan was published on 12 May 2014 and the Section

151 Meeting held on 22 May 2014. The meeting was adjourned for purposes of amending the

Business Rescue Plan and adopted at a meeting convened for 22 September 2014.

7. An amended business rescue plan was published in conjunction on 7 July 2016 and adopted

by all creditors.

8. On 29 October 2019, Business Partners Limited, an affected person and creditor, issued an

application for the business rescue proceedings of the company to be converted to liquidation

proceedings and which application the BRP's do not intend opposing. The court papers were

served on the BRP's on 6 November 2019.

9. The application for the company's liquidation will be on the roll for 27 November 2019. The

company was placed into liquidation on 27 November 2019 and a liquidator appointed.
