2. Current Status of Business Rescue Proceedings

- 2.1 Publication of Proposed Business Rescue Plan
- 2.1.1 The BRP published his proposed business rescue plan on 16 July 2021;
- 2.1.2 The minority shareholder of the Company, being Blue Nightingale Trading 709 (Pty) Ltd launched an urgent application to interdict the section 151 meeting from proceeding and on the 25th of July 2021, the BRP was interdicted and retrained from proceeding with the meeting convened in terms of the requirement of section 151 of the Companies Act, pending the outcome of the hearing of Part B of the matter in which BNG would seek a setting aside of the business rescue proceedings;
- 2.1.3 the parties duly filed further papers and Part B of the application was heard on the 17th and 19th of August 2021, with judgment being reserved.
- 2.1.4 Judgment has now been handed down in the matter and the application was dismissed with costs.
- 2.1.5 The BRP's received notice of an application for leave to appeal and opposed the application. The leave to appeal was heard on the 2nd of December 2021, with judgment being reserved.
