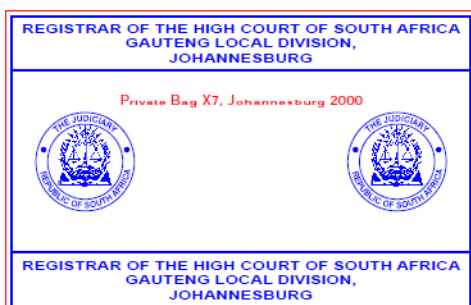

3. A *rule nisi* is hereby issued calling upon the First Respondent and all Affected

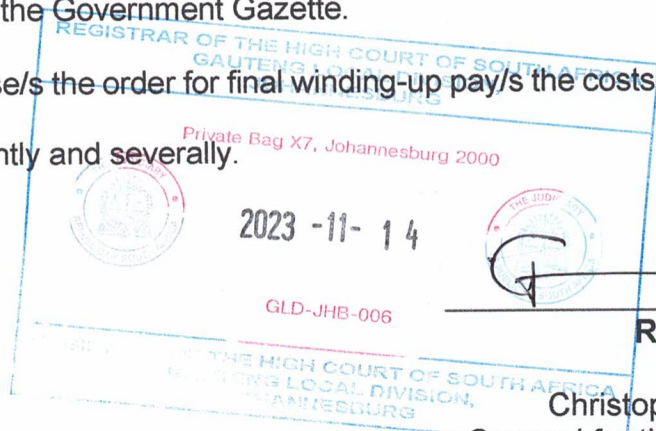
