- 6.2 Over spending on salaries and wages
- 6.3 Suspected theft of the company's products
- 7 As a result of the above:
- 7.1 The company is experiencing cashflowconstraints;
- 7.2 The company has been or will shortly be unable to service payments in respect of its month to month obligations to creditors and more specifically in terms of its credit facilities;
- 7.3 The Company is unable to finalise orders from clients due to a shortfall in working capital requirements; and

LEGAL PROCEEDINGS

To the best of my knowledge, I confirm that there are no active liquidation proceedings or any other litigation proceedings that have been initiated by or against the Company.

PROSPECTS FOR RECOVERY IN BUSINESS RESCUE

- It is my firm belief that there are reasonable prospects for the rescue and recovery of the company through the utilisation of the business rescue processes envisaged in chapter 6 of Act.
