practitioners, subject to:

2.2.1 confirmation of compliance with the requirements of section 138 of

2.2.2 written consent and acceptance of such appointment.

2.3 That in the event that Mr van der Merwe, Mr. Schapiro or Mr. Chittendan

resign as business rescue practitioners, then the Company hereby

nominates Mr John Francis Evans of RS Advisors (Pty Ltd and/or Mr. Ian

Flemming of Engaged Business Turnaround.

of the Company, to depose to the affidavit in support of this resolution and
