### 2. Current Status of Business Rescue Proceeding

## 2.1 Publication of the Proposed Business Rescue Plan

2.1.1 The proposed business rescue plan was published on 10 September 2025.

## 2.2 Meeting to determine the future of the business

2.2.1 The section 151 meeting of all affected persons was held on 23 September 2025 to discuss the future of the business. During this meeting, a request was made by a requisite majority of creditors with a voting interest to postpone the meeting to 30 September 2025.

2.2.2 The adjourned meeting took place on 30 September 2025 and the proposed business rescue plan was adopted by 100 percent of creditors present and voting at the section 151 meeting of affected persons.

## 2.3 Proof of Claims

2.3.1 Creditors who have yet to submit their claims are encouraged to do so.

2.3.2 Bassani Medical, together with the BRPs, are reconciling the claims received to date and will communicate with creditors, individually, regarding the status of their claims.

2.3.3 The BRPs have communicated with creditors inviting them to resubmit claims. The BRPs have started adjudicating all claims received. There are ongoing discussions with creditors to date.

## 2.4 Operational engagements and agreements

2.4.1 The BRPs have held detailed discussions with Bassani Medical's management regarding various operational matters. These engagements have culminated in the conclusion of agreements that regularise and formalise inter-group commercial relationships.

2.4.2 The BRPs have been approached by a party seeking to acquire the assets. We are currently engaging the parties; we have received an offer to purchase the assets; no sale of asset agreements have been concluded to date.

2.4.3 The BRPs will now attend to implement the business rescue plan, as adopted.
